

Hosting PGC Sessions

Parishes are encouraged to host PGC. Classes can be as small as 15 or as large as 150, depending on the equipment limitations of the site. To arrange a PGC session at your parish, contact Regina Quinn, 614-241-2568 or rquinn@cdeducation.org.

How do I find where the sessions are being held?

The current schedule is always posted on the VIRTUS website.

Go to: www.virtus.org. Click on the Yellow Registration button just beneath the login.

Choose "View a List of Sessions."

Registration is also done from this site, and pre-registration is required.

Establishing a Safe Environment

A fundamental goal of the Catholic Church is to prevent future occurrences of sexual abuse of children by anyone associated with the Church. In 2003, the Diocese of Columbus published its decree which established policies dealing with allegations of sexual abuse of minors.

One of those policies was the creation of a Safe Environment Program designed to protect children while they are in the care, custody or control of any person working on behalf of the Church.

Protecting God's Children™ training is just one step of the overall Safe Environment Program.

What *is* Protecting God's Children™ (PGC)?

Protecting God's Children™ is a three-hour introductory workshop designed to raise awareness about the reality of child sexual abuse. Through videos and facilitated group discussion format, the session helps participants become more familiar with the issues and myths surrounding child sexual abuse; signs of sexual abuse in children; behavioral patterns of perpetrators; steps the Church is taking to prevent future abuse; and a plan of action for adults to remain watchful for would-be perpetrators.

What PGC *isn't*!

PGC is *not* a punishment or an accusation against volunteers. On the contrary it illustrates how, through increased awareness and vigilance, all adults can become part of the solution to stopping child sexual abuse.

PGC is *not* intended to be catechetical in nature and assumes participants have other opportunities for catechesis on the Church's teaching on chastity and human sexuality.

Why is it important to attend a session?

If we want to prevent predators from gaining access to our children, we need to know what to watch for, how to spot and handle situations before they escalate, and how to report suspected abuse.

Who is allowed to take it?

Any adult who is interested in learning how protect children from sexual abuse is welcome to attend. Being a volunteer is not a requirement. (However due to the content, minors are not allowed.)

Who is required to take it?

The following adults are required to attend Protecting God's Children:

-All parish, school and diocesan employees, *regardless of their level of contact with children*

-All clergy and applicants to clerical formation who serve in the diocese

-Every volunteer in a school, program or ministry for children and youth, *regardless of their level of contact with children*

-Volunteers for *other* parish programs or ministries who have been delegated care, custody or control of children

Continuing Education Requirements
